# Highlights – VAT – Maharashtra Budget 2015-16

The Hon. Finance Minister (Maharashtra State) presented Budget 2015-16. Following are the highlights of the amendments proposed in Maharashtra VAT & Profession Tax laws. The amendments will be effective from the dates to be notified:

#### I <u>Changes in rates:</u>

#### II <u>Other rate related changes:</u>

- 1 Items covered under description "paper" (5%) will be notified
- 2 Mixture of spices will be treated as spices, liable at 5%.
- 3 Tax on embroidery thread will be same as that of sewing thread.
- 4 Entry Tax: 5% entry tax on long steel; will be eligible for set off as per provision.
- 5 Exemption on rice, wheat, pulses & their flour, turmeric, chilies, tamarind, Jaggery, coconut, coriander seeds, fenugreek, parsley, papad, wet-dates, currants & raisins, solapuri chaddars & towels to continue upto 31<sup>st</sup> march 2016.

- 6 Lower rate of 5% on tea to continue upto 31<sup>st</sup> March 2016
- 7 Wherever VAT as well as service tax are levied in composite contracts, VAT will not be levied on service tax collected separately.
- 8 Rate of excise duty on country liquor would be 100% of the manufacturing cost or Rs. 120 per proof liter whichever is higher.

### III Abolition of Local Body Tax (LBT):

LBT to be abolished from 1<sup>st</sup> August 2015. Loss of revenue to Municipal Corporations (except Mumbai) will be compensated by enhancing rate of VAT in entire state.

#### IV Other amendments:

- 1. To allow multiple revised returns in case of audit findings or investigation proceedings by sales tax authorities.
- 2. Late fee for delay in filing of return upto one month, reduced from Rs. 2000/- to Rs. 1000/-
- 3. To introduce time limit for completion of transaction wise assessment & provide for cancellation of order if the order is done ex-parte. Change in method of calculating interest on extra tax becoming due on revising returns to calculate interest from 1<sup>st</sup> October of the relevant year.
- 4. Re: Merger or demergers: After High Court approves merger or demerger of companies, the company is required to apply to the registrar of companies (ROC). It is proposed to specify a period of 30 days to apply for VAT registration from the date of notification by ROC

#### V Profession tax:

Women drawing salary upto Rs. 10,000/- per month, exempt from profession tax (Current limit is Rs. 7500/- p.m.)

#### **General:**

The sales tax dept. is strengthening e – services for seedy disposal and the State Government is gearing for forthcoming Goods & Service Tax (GST).
